

St. Montfort Award Illustrious Service Award

The St. Montfort Award was named after St. Louis Marie Grignion de Montfort (1673-1716), the founder of the Brothers of St. Gabriel. He is our spiritual master who walked before us toward the Living God. Following in his footprints, we can proceed on a path to union with God. The Brothers of St. Gabriel in Thailand consider him to be a model for a religious life and for their educative mission.

This award is given for faithful, dedicated and outstanding services rendered to the University by senior administrators whose career spans more than twenty-five years.

St. Michael Award Public Service Award (First, Second, and Third Class)

The St. Michael Award was named after St. Michael the Archangel, the protector of the people of God.

The award also honors the name of Brother Michael, one of the 13 French Brothers who moved from Thailand to India during World War II. He was appointed master of novices at Eachinkadu, Yercaud, South India, tasked with the training of a number of senior Brothers of the Province of Thailand.

This award comes in three classes and is given to University members who have provided academic and/or other significant services to society, and who have represented the University in academic and supporting activities that are acknowledged by the public. In so doing, they uphold and promote the University's reputation and stature.

> St. Hilaire Award Distinction in Writing Award (First, Second, and Third Class)

The St. Hilaire Award was named after St. Hilaire who was born at the beginning of the fourth century at Poitiers in France. He was a bishop and Doctor of the Universal Church.

Brother Hilaire was one of the first five pioneering Brothers to arrive in Thailand in 1901. He was a well-known educator at Assumption College, Bangkok. He mastered the Thai language so well that he became an unparalleled Siamese Linguist. He wrote Thai language manuals, the first of which, Darun Suksa, was considered by all as the very best source for the learning of the Thai language.

This award comes in three classes and is designated for those who achieved distinction through academic writings in the form of articles and books.

St. Martin de Tours Award Excellence in Performance Award (First, Second, and Third Class)

St. Martin de Tours, for whom St. Martin de Tours Award is named, was a Roman soldier raised in Italy. Finding God, he converted to Christianity and became an unwilling soldier. Later he was a disciple of Hilaire of Poitiers and, still later, became the Bishop of Tours. The award was also named in memory of Brother Martin de Tours, one of the five Brothers who first entered Siam on October 20, 1901.

This award is designated for lecturers and administrators: who discharged their duties and responsibilities conscientiously and superbly: who exhibited high standards of efficiency, excellence and quality in teaching, counseling, and duties such as composition of test materials, framing of examination papers and other academic related factors. The award is also for non-teaching staff who add to the University learning process.

St. Bernard Award Special Merit Award (First, Second, and Third Class)

The St. Bernard Award was named after St. Bernard (1090-1153), an abbot and later named Doctor of the Church. He was a Cistercian monk. He wrote profusely and movingly concerning the Lord Jesus, spirituality, the Scriptures, and the Blessed Mother.

The award also recognized Brother Bernard Mary whose idea of adding a degree program to the existing Assumption Commercial College (ACC) program that eventually led to the establishment of ABAC and hence Assumption University.

This award is intended for University members who exhibited special managerial skills, and who performed their tasks and assignments beyond the normal calls of duty such as initiating, restructuring or reengineering of programs for an office or department, or providing voluntary services for improving, upgrading systems and procedures, and participating in other artistic or scientific activities for the welfare of society.

St. Thomas Aquinas Award Research Award (First, Second, and Third Class)

The St. Thomas Aquinas Award was named after St. Thomas Aquinas in respect for his special talents that he devoted in full measure to the search for the Eternal Truth. St. Thomas Aquinas was a great Dominican teacher (1225-1274). He traveled and wrote extensively. His two *Summas* should not obscure his other biblical, theological and philosophical writings. He dedicated his brilliant talents to the investigation of the

sublime truth of God in the light of faith and the human intellect. He is the patron saint of all Catholic schools.

This award is given to those who contribute through their research to the promotion, enhancement or the reputation and prestige of the University. Their research should result in publications, patents and/or other innovative materials or feature.

St. De La Salle Award Commendable Service Award

The St. De La Salle Award is named in honor of St. De La Salle, a learned man and Patron Saint of all teachers, who is credited with writing the pedagogy of the teaching profession and the twelve virtues of teachers.

This award recognizes and rewards faculty members who have served exclusively as lecturers for over twenty-five years at Assumption University, maintaining high standards of excellence in their profession.

St. Joseph Award Dedicated Service Award

The St. Joseph Award is named after St. Joseph. The bible mentions him as a humble and just man. The Catholic Church has proclaimed Saint Joseph as the Patron Saint of all workers.

This award recognizes and rewards full-time staff members who, having served at Assumption University for at least twenty-five years, in their everyday work and roles, go beyond themselves in bringing service with satisfaction to their colleagues and students, in selfless ways.

Research Fellow

The title "Research Fellow" is conferred upon a distinguished Professor or Lecturer before he retires from active service at the university.

Individuals appointed to this honorary position display a deep love for research as a pathway to truth. Their endeavors in revealing inspirational truths through research are indeed commendable and worthy of recognition.

This recognition also includes individuals who have contributed, through their intellectual works, to the strengthening of the university's expertise either through writing textbooks, creating a faculty or setting intellectual standard for academic connaissances.

It is an honour that the President graces the conferral ceremony for AU Awards for Excellence 2017. Prior to the awards conferral, I would like to present you the historical background, philosophy and objectives of the AU Awards for Excellence and the significance of the awards for Assumption University's community.

The AU Awards for Excellence was officially initiated on 22 July 1993 by Rev. Bro. Prathip Martin Komolmas. He initiated the policy which he wrote: "Those who have sacrificed their lives and time by their creative loyalty and positive contributions to the institution must be recognized, promoted and rewarded."

The first conferral of awards was initiated in 1997 under the name AU Academic Awards under six categories. Then, three-tier system of achievements: first, second, and third class, with the first as the highest in each category was announced in 1999 to take effect in 2000. In the year 2000, the name of the awards was changed to AU Awards for Excellence. In 2008, the President of Assumption University decreed the inception of the Professor of the Order of St. Gabriel as part of the annual award ceremony to honour faculty members who are dedicated to teaching and providing service through other avenues within the university.

Since its conception, Assumption University has always deemed it appropriate to acknowledge the contributions of everyone within the university community, especially individuals who have contributed immensely to the success and attainment of academic goals of the university. Acknowledgement of such sacrifice, commitment and dedication to teaching, research, administration and service is a graceful act. Individuals who have shown such dedication and hard work are worthy of recognition and award.

- 6. St. De La Salle Award for Commendable Service to fourteen faculty members,

Assistant Professor Dr. Warayuth Sriwarakuel

Awarded St. Montfort Award for Illustrious Service

Citation

Asst. Prof. Dr. Warayuth Sriwarakuel has played many important roles at Assumption University. Currently he is the Vice President for Research and Academic Services. But he also plays the roles of a teacher, a researcher, an advisor, a thesis/dissertation examiner, an editor, an IQA assessor, an EQA assessor, a peer reviewer, a project assessor, a guest speaker at many national and international conferences, and a servant leader.

His earlier life has been devoted to service to the church, to education, and to the community. When he was young, he was trained as a Catholic seminarian for ten years (1967-77). Later he worked as a teacher in a secondary school in Sakon Nakhon teaching students English and Ethics for two years. After he received his bachelor's degree, majoring in English from Srinakharinwirot University, Prasarnmit campus, in 1981, he went to teach English to Laotian refugees in Nongkhai Refugees Camp for six months before continuing his studies for a Master's degree.

He received his MA in Philosophy from Chulalongkorn University in 1985. During his master's studies, he also worked for two years as a credit and stock analyst in a company on Silom Road. After he had recieved his Master's degree, he continued working at Phanat Nikhom Indo-Chinese Refugees Holding Center, Chonburi, for seven years as an ESL teacher, a Cultural Orientation instructor, and a program coordinator. Then he moved to Bangkok and joined Assumption University in June 1992. He finished his Ph.D. in Philosophy from Chulalongkorn University in 1996.

Dr. Warayuth has taught at Assumption University since June 1 1992. He began as a full-time lecturer teaching undergraduate students logic and philosophy. He was then appointed as Dean of the Graduate School of Philosophy and Religion on May 1, 1999. He served as Dean for 16 years (from May 1999 to July 2015). He was also appointed Assistant Professor in October 1999.

As a teacher in Assumption University, Dr. Warayuth has taught different courses to MA and Ph.D. students. The subjects he has taught include process studies, epistemology, metaphysics, hermeneutics, research methodology, history of Western thought, philosophy of science, philosophy of social science, philosophy of religion. Process Studies is his most favorite subject because it requires the researcher to be both "jacks of all trades" and "masters of all." He has also taught professional ethics which is important for undergraduate students. He has always enjoyed teaching and learning from students. It is not exaggerated to say that he was born to be a teacher.

After having joined Assumption University for some time, in 2000, he participated in a Postdoctoral Research Program conducted by the Council for Research in Values and Philosophy, Catholic University of America. This organization was created by Prof. George McLean's whose life and thought, has had a deep impact on him up to the present time.

As a guest speaker, Dr. Warayuth has been invited to give special lectures on philosophical and religious thought at various universities and colleges around Thailand. Those educational institutes include Chulalongkorn, Thammasat, Mahidol, Kasetsart, Mahachulalongkorn, Mahamakut, Burapha, Ramkhamhaeng, Srinakharinwirot, Silpakorn, Khonkaen, Rambhaibarni Rajabhat, Payap, Bangkok, Rangsit, Krirk, St. Louise's, and Saengtham. Oftentimes he has been invited to be a guest speaker or a panelist abroad. Surprisingly, in Thailand he is recognized as a Catholic scholar, but in abroad he is recognized as a Buddhist scholar. If anything about Buddhist thought, scholars appeal to his expertise.

Dr. Warayuth was the editor-in-chief of the journal *Prajñā Vihāra* (2002-2012) which has been issued every six months to promote justice, peace, harmony, and mutual understanding among peoples in the world. It serves as the first journal of philosophy in Southeast Asia that has been recognized by the Philosopher's Index, the premier philosophy database, issued by the Philosopher's Information Center, a nonprofit, educational organization dedicated to serving the global philosophical community. The journal was funded by the Office of Higher Education Commission three years in succession.

He is also asked to serve the scholarly community in the region. As a peer reviewer, Dr. Warayuth has been appointed to read and evaluate papers of those who have applied for academic titles, and for publishing in various academic journals in South East Asia. These journals include Saengtham College Journal, Manusya (Chulalongkorn University), Philosophia (De La Salle University), and Journal of the Philosophy and Religion Society of Thailand.

As an advisor, Dr. Warayuth has supervised both MA and Ph.D. students in writing their theses and dissertations. He has always maintained very rigorous standards for student research and writing. As a thesis/dissertation examiner, Dr. Warayuth serves both students in Assumption University and those in other universities both in Thailand and abroad. His comments and recommendations for students are always warm but also strict and straightforward. He always encourages students to follow Kantian Spirit of Enlightenment: *Sapere aude!* which means "Dare to think for/by yourself."

Asst. Prof. Dr. Warayuth has also served the Office of Higher Education Commission (OHEC) and the Office for National Education Standards and Quality Assessment (ONESQA) as an IQA and an EQA assessor respectively. He has been an EQA assessor since 2006 and an IQA assessor since 2008. He has assessed both public and private universities and colleges at the school and at the institute levels. What he has learned from other institutes has been shared and applied in his School and other faculties in Assumption University. As a researcher, Dr. Warayuth believes that conducting research is one of the main missions of university professors. The ability to do research distinguishes a university instructor from a school teacher. Dr. Warayuth has written and edited four books and published more than fifty articles, mostly in English. He is not reluctant to attend or participate in any conference, nationally or internationally, whenever he has a chance in order to learn something new and share it with his colleagues and students. He realizes that no one can give what s/he does not have and that no one can teach what s/he does not know.

Dr. Warayuth has served philosophy and the University in other ways as well. As a project assessor, he evaluated Chulalongkorn University's cluster of projects in 2011-2013. As a servant leader, he served as Vice-President of the Philosophy and Religion Society of Thailand (2001-2004), President of the Asian Association of Christian Philosophers (2004-2006), Regional Coordinator of the Council for Research in Values and Philosophy (2004-present), President of the Philosophy and Religion Society of Thailand (2009-2012), Committee Director of the International Federation of Philosophical Societies (2009-2014), and Member of the Subcommittee on the Promotion of Religious Affairs and Inter-Religious Relations, the Senate, Kingdom of Thailand (2011-2014).

He has served the University in different working groups and committees for years. Three of his favorite mottos are "To be is to be for others," "Our happiness is to make others happy," and "We are what we do." He always encourages his colleagues to follow what he calls "Jesus Christ's Equation of Satisfaction" or "The Two-Mile Spirit" as Jesus said: "And if anyone forces you to go one mile, go with him two miles." This means that our performance should always double other's expectations.

In 1993, he was awarded funding by United Airlines to go to the United States to attend the ninetieth annual meeting organized by the American Philosophical Association, Eastern Division, in Atlanta, Georgia. In 1998 and 2008, he was given St. Hilaire Award and St. Bernard Award (First Class) respectively by the University. The Fifth Class, Fourth Class, and Third Class of the Most Admirable Order of the Direkgunabhorn were bestowed upon him in 2000, 2006, and 2012 respectively. In 2010, the Association of Private Higher Education Institutions of Thailand awarded him as an excellent academic. He is the second faculty member from Assumption University getting this award from this organization.

Due to his outstanding services and dedication, Assumption University is pleased to award Asst. Prof. Dr. Warayuth Sriwarakuel St. Montfort Award for Illustrious Service on the auspicious date of December 24, 2017.

Asst. Prof. Dr. Jirayu (Poomontre) Kasemsant is a full-time faculty member of the Department of Marketing, Martin de Tours School of Management and Economics and director of career training center of Martin de Tours School of Management and Economics. He earned a Bachelor of Applied Statistics (2nd Hons) degree from King Mongkut Institute of Ladkrabang, three post-grad diplomas from King Prajadhipok's Institute (Thailand) in Executive Program in Public Economics Batch 5 and AEC Batch 4 and Executive program in Real-estate Marketing from School of Architecture (Chulalongkorn University) Batch 6, three Master degrees from Chulalongkorn University in Statistics, Wollongong University (Australia) (AU Scholarship) in Business Information System and National Institute of Administration Development (International Program) from National Institute of Administration Development (Thailand). He joined Assumption University in 1990.

In addition to his teaching duties, as director and founder of career training center of the Martin de Tours School of Management and Economics. Asst. After that he became a Marie Curie Early Stage fellow under the project From Mathematical Logic to Applications, which entitled him a faculty position at the University of Manchester, U.K., which he held for two years. From this university he received a Ph.D. degree in mathematical logic in 2014.

He has been a faculty member of Assumption University of Thailand since 2014 and effectively became an assistant professor in mathematics in June 2015. From August 2017 he is based in the Department of Business Economics, Martin de Tours School of Management and Economics. During his service he has provided research reviews first as a member of the school's research review board and later as a member of the Research and Academic Services Support Committee.

The main research interest of Assistant Professor Dr. Martin Adamčík is to apply logic and probability to practical inferences about the real world, fulfilling the aim of the fellowship that kick-started his career. To this end, he has developed a new method for meta-analysis that deals with both complex knowledge and unexplained heterogeneity. A research paper explaining this method by combining several medical studies concerning the one-year incidence of diagnosis of cancer in patients with unprovoked venous thromboembolism was published in the Journal of Biomedical Informatics, a leading journal in the field indexed in the Science Citation Index.
